Expected Outcomes:

- Ensure ready to let homes are homes we can be proud of, and all necessary information is readily available.
- Collaborate with external stakeholders to identify potential residents, ensuring suitability and tenancy sustainability.
- Communicate clearly with residents ensuring a smooth lettings process which allows them to quickly settle into their new home.
- Proactively manage sourcing potential residents, viewings and lettings to minimise void periods.
- Be responsible for quality control, ensuring new residents are offered safe, compliant and good quality homes.
- Ensure resident satisfaction with their new home, providing a proactive follow up service to understand any resident issues or concerns.
- Communicate effectively with empathy, ensuring residents are kept informed and updated on the progress of issues affecting them.

How you'll do it

- Undertake quality control inspections of ready to let homes, ensuring they meet all standards and are safe and compliant.
- Actively seek potential residents, assessing suitability and affordability and preparing necessary documentation.
- Foster strong relationships with potential residents, conducting viewings and lettings in person.
- Prepare and execute all necessary documentation and information with precision and attention to detail, ensuring that all required processes are completed effectively.
- Advocate on behalf of our residents for high quality homes within the portfolio.
- Collaborate with colleagues across Operations and NHG to provide excellent services for all customers.
- Maintain contact with residents whilst they settle into their new homes, providing a responsive service to address any concerns.
- Monitor and control the lettings process to deliver on KPI's and support with reducing void turnaround times.
